Hagley Museum is located on 235 acres along the banks of the Brandywine River in Wilmington, Delaware. Hagley is the site of the gunpowder works founded by E. I. du Pont de Nemours in 1802. This example of early American industry includes restored mills, a workers' community, and the ancestral home and gardens of the du Pont family. Hagley exhibits objects and artifacts that interpret the unfolding history of American business, technology, and innovation, and its impact on the world.

Hagley's Research Library supports research on the history of American business, commerce, consumption, technology, and design within their broad social, cultural, and political contexts. Each year hundreds of scholars come to the Library to do research using Hagley's materials and archives. In 1986, the Center for the History of Business, Technology, and Society was organized to administer Hagley's interactions with the world of scholarship.

Purchases of collection items are recorded as decreases in net assets without donor restrictions in the year in which the items are acquired or as decreases in net assets with donor restrictions if the assets used to purchase the items are restricted by donors. Proceeds from de-accessions or insurance recoveries are reflected as increases in the appropriate net asset class.

The collections are held for public exhibition, education, or research in furtherance of public service rather than financial gain. They are protected, kept unencumbered, cared for, and preserved. The collection maintained by Hagley Library (the "Library") is subject to a policy that requires the sales proceeds of collection items to be used to acquire other items for collections. The Executive Director gathers local salary data as well as national salary survey data every other year in order to establish current market values for Hagley's salaried positions. The collected survey data supports a salary structure that aligns every position within a salary range. The Executive Director works with the Organization and Compensation Committee under the Board of Trustees in order to ensure that the proper appraisal systems and compensation and benefits philosophies approved by the Committee are adhered to by management.
